- m. Analysing outcomes and writing detailed progress reports.
- n. Valuing completed work and arranging payments.
- o. Maintaining awareness of the different building contracts in current use;
- p. Understanding the implications of health and safety regulations.
- q. Contract Award, execution and Implementation: after securing approval, contracts are then awarded to successful bidders and subsequently mobilized to site. The procurement Unit then monitors the execution of the project and recommend for payments after netting interim valuation certificated issued by the Quantity Surveyor or appointed project consultants.
